Entry Form Deadline: Entries must be received no later than 10 pm, Tuesday, Sept. 5th. Please send Rabbit entry forms to Cristina Posey, 9536 Chemainus Rd., Chemainus, BC V0R 1K5 or cell (250) 252-0695 or bunnylady17@gmail.com. E-mail or phone entries preferred. Day of show entries - \$5/entry.

Rules:

- a. This is an ARBA sanctioned show to be governed by the latest ARBA rules. These rules can be read on-line on the official ARBA website (www.arba.net). They will also be posted in the showroom.
- b. Exhibits must be tattooed in the left ear. If you plan on having the Fair Committee tattoo your rabbits, please indicate proposed tattoo on entry form (\$2 fee).
- c. All rabbits must be in the showroom by 8 am, Saturday, Sept. 9th, 2017. Rabbits can also arrive Friday, Sept. 8th, between 7 and 9 pm.
- d. Judging commences at 9:30 am on Saturday, Sept. 9th and at 8 am on Sunday, Sept. 10th. No animal may be removed from its carrying cage other than for judging. Leak-proof cages only please!
- e. Exhibits must be bona fide property of exhibitor for at least 30 days prior to the show.
- f. All animals will be judged in the class as written on the entry form. No substitutions will be allowed except in the same breed, sex and class.
- g. Make out the entry form carefully and include breed, variety and/or colour, sex, class (age), and ear number (tattoo). If in doubt, call the Chairperson.
- h. Any rabbit showing symptoms of disease of any kind will not be allowed in the show room.
- i. There will be no advertising or selling of PET rabbits or covies at the show. Any other sales allowed only with the consent of the Chairperson, and only exhibitors with animals entered in the show can sell stock. Animals sold must be in proper animal carriers and can leave only at the end of the day. If these rules are violated you will be asked to remove your animals from the Fairgrounds.
- j. No ear number changes allowed during judging.
- k. All rabbits and covies must have adequate water AT ALL TIMES during their stay at the Fair and be offered their ration of food each day in secure dispensers on the cage.
- l. Rabbits must be of at least 7 weeks of age, or have reached the minimum weight for the breeds' standards. This includes all animals in the showroom, not only the animals entered in the show. The Chairperson will ask you to remove your animals from the Fairgrounds if these rules are violated.
- m. **3-Day Exhibitor's Pass:** \$15. The regular gate entry fee for adults is \$10 per day.
